You are also requested to send a SBI Bank Draft for Rs.100/- (Rs. 50/- for SC/ST Candidates) drawn in favour of the **Principal, Sainik School Kalikiri, payable at SBI, Kalikiri Branch, IFS Code SBIN0016427 as the fee for Appeal Medical along with a Certificate as mentioned above, positively to reach the School on or before 31 Mar 2018.** If there is no response from your side by the above stipulated date, the candidature of your son/ward for admission to classes VI/IX will be deemed cancelled without any further intimation.

3. If in the opinion of the School authorities, your case merits a review, you will be informed telephonically/by e-mail about the date of Medical Examination. The Candidate will be required to appear before the Appeal Medical Board at Military Hospital, Trimulgherry, Secunderabad at their own expenses. The Candidate will get admission in the School only subject to being declared **MEDICALLY FIT** by the Appeal Medical Board.

**Note for Waiting List Candidates:** Please note that your son/ward is in the **waiting list** and will get admission in the School only subject to availability of vacancy and he being declared **MEDICALLY FIT** by the Appeal Medical Board.
