- If in the opinion of the School authorities, your case merits a review, you will be informed telephonically/by e-mail about the date of Medical Examination. The Candidate will be required to appear before the Review Medical Board at Military Hospital, Trimulgherry, Secunderabad at their own expense. Please note that your son/ward is in the **Main list** and will get admission in the School only subject to being declared **MEDICALLY FIT** by the Review Medical Board.
